- Claims totaling \$14 million raised against a government owner due to alleged owner-caused delays and design defects relative to a substantial wastewater treatment plant construction project
- A \$7.4 million breach of contract claim related to alleged extra work relative to an emergency construction contract
- A \$1.4 million differing site conditions claim against a government owner in which the contractor alleged it encountered subsurface site conditions that differed from the contract’s specifications

Mr. Dimenna is a resident of Baltimore City. He is committed to serving his fellow residents by advising and representing small local business owners and protecting the general interests of taxpayers in his role as outside counsel for the City in a number of construction contract disputes.
